

### RULES & REGULATIONS – PROPEXPO KENYA 2026

1. Space is allocated on a first-come, first-served basis with advance payment. Incomplete bookings are not accepted.
2. Cancellation Policy
  - Before Jan 15, 2026 - 100% refund
  - Before Jan 30, 2026 - 50% refund
  - Before Feb 15, 2026 - 25% refund
  - After Feb 28, 2026 - No refund
 (All refunds subject to VAT)
3. Organizers may reallocate space. Exhibitors must follow official drawings/specs and complete setup before show opening.
4. Contracts void if exhibitor goes bankrupt. Subletting requires prior organizer approval.
5. Exhibitors are responsible for insuring exhibits, covering damages/loss, and meeting safety requirements.
6. No liability for cancellations due to events beyond control (natural disasters, strikes, etc.). Refunds only if the event is fully cancelled.
7. Organizers may photograph/film exhibits for promotion and enforce rules at their discretion.
